registration number **4740945**, using cooled, transported semen for the ____ breeding season.

1. The stallion fee for cooled transported semen is \$ _____. This included the \$ 500.00 non-refundable booking fee which is payable upon execution of the contract. There is a \$ 300.00 charge per shipment for collection, preparing & shipping. The remainder of the stallion fee and the first shipping charges are due ten (10) days prior to shipment or the semen will not be sent. 13% HST will be added to boarding, shipment and stallion fee. (not applicable to US shipments.)
2. A photocopy, both sides, of the registration papers on your mare must accompany this contract. The owner recorded on the registration certificate will be the owner recorded on the stallion breeding report.
3. Mares on the premises of StoneRidge have a breeding priority on any given breeding day. Therefore, we make no guarantee that cooled semen will be available for transportation on any specific day.
4. StoneRidge collects stallion on Monday, Wednesday and Friday. No Exceptions! StoneRidge breeding will start March 17 through July 1.
5. A request for a shipment of cooled transported semen must be made at least 24 hours prior to shipping time. Cancellation must be made by 8:30 am (Central Time) shipping day. Failure to cancel by 8:30 am (Central Time) will result in a shipping charge. Cancellations can be made by telephone. Semen will only be sent via Fedex. If semen is needed the same day via an airline, if available, Mare Owner will be responsible for the additional charge of \$100.00 to counter to counter ship the semen.
6. This contract contains a "Live Foal Guarantee". A live foal is described as a newborn foal which stands and nurses without assistance. If a foal is born dead, or the mare absorbs/aborts a predetermined pregnancy there are return privileges, only if the stallion owner is notified within thirty (30) days and receives a statement confirming this. A "Live Foal Guarantee" will apply only to those mares that are certified in foal by a licensed, attending veterinarian. Confirmation of such pregnancy in the form of a letter or fax from the attending veterinarian must be received by October 1 of the breeding year.
7. If the mare absorbs or aborts a pregnancy after having been checked in foal, or if the mare fails to conceive during the normal breeding season, the Stallion Owner agrees to breed the same mare again during the immediately following year's breeding season. There is a chute fee charge of \$ 250.00 for re-breed service expenses plus a shipping fee of \$ 300.00. A substitute mare, accepted by the Stallion Owner, may be used ONLY if the original mare is deceased or deemed unfit for breeding by an accredited veterinarian.
8. A Breeder's Certificate will be issued for the foal conceived as a result of the breeding. The Breeder's Certificate will be issued only after all expenses have been paid in full and upon notification of the birth of the foal to the Stallion Owner.
9. Neither StoneRidge nor any of its officers or employees shall be liable for damages as a result of damage to the semen or as a result of a mare failing to settle. StoneRidge's sole liability under this contract is in the event the stallion should die or become unfit for breeding purposes this contract shall terminate and any money paid on the stallion fee, except the non-refundable booking fee, shall be refunded to the Mare Owner.
10. This contract shall be governed by the Laws of the Province of Ontario and is hereby executed as of the date signed by the Stallion Owner which date shall govern the effective dates of said contract.
